Germany	Combined study and placement semesters abroad for students and masters students - DAAD	This program offers you the opportunity to gain international study and practice experience. The combination of a semester of study and a semester of practice allows you to gain an international qualification both academically and practically. The scholarship is awarded for a total duration of 7 months minimum to 12 months maximum. The duration of the scholarship depends on your project. The duration and organization of the practical semester (minimum 2 months) depends on the study program of your institution in Germany. 	Starter-Kit Bayern-France	This financial aid is aimed at any student enrolled in a French or Bavarian university (or Grande Ecole) wishing to study or do a research placement in the partner country. The mobility grant consists of a fixed sum of $\xi$ 500, independent of the duration of the stay and a flat-rate allowance for travel costs of up to $\xi$ 450, (between the place of the home and the host university). Australia	Nicolas Baudin Programme	The Nicolas Baudin Student Mobility Programme's "Internships in France" initiative offers students from participating Australian universities research internships in France in collaboration with an industrial partner. It offers the financing of the beneficiary's stay in France, for a period of 6 months (from 09/01/2022 to 02/28/2023), but it will have to be ensured by a complementary financing of at least 390 euros per month. 	Scholarship Metchnikov	Within the framework of its Metchnikov programme for the mobility of researchers, the French Embassy in the Russian Federation awards grants to Russian researchers invited to work in a French research team, attached to a higher education institution, a research organisation or a company, for a period of 1 to 3 months. All scientific disciplines are concerned. The selection process for the 2022-2023 Ostrogradski Fellowship Programme is heavily impacted by the current international situation. Turkey	Scholarships co-financed by the French Embassy in Turkey and the TEV Foundation	TEV and the French Embassy offer scholarships for Master2 and, under certain conditions, for the first year of Master1 in France (the duration of the scholarship is 10 months and cannot be renewed). The language of instruction is French and English (preferably C1 level and at least B2 level) and the duration of the Master's programme is 1 year in French public universities. Applicants who will study in English must have a certain level of French. Ukraine	Temporary protection in France	Temporary protection is an exceptional measure authorised by the Council of the European Union decision of 4 March 2022. It allows you to benefit from: - the issue of a temporary residence permit on French territory for a period of 6 months, bearing the words "beneficiary of temporary protection"; - the payment of the asylum seeker's allowance; - authorisation to exercise a professional activity ; - access to care through medical care; - schooling for minors ; - support in accessing housing. Students protected by this status can also access : - emergency assistance from the CROUS of their host institution; - scholarships on social criteria awarded by the CROUS; - 1 meal in a university restaurant.
